Sir,

This is with reference to above mentioned subject regarding extension of provisional approval of affiliation to **KLE College of law, (Karanataka Lingayat Education Society), Navi Mumbai, Maharashtra** which is already applied for extension of approval of affiliation for the academic year 2017-18 and inspection of the Bar Council of India is pending.

The matter was considered by Bar Council of India at its General Council meeting held on 5th May, 2017. After consideration the Committee passed the following resolution:

“RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2017-2018. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently.”

Since your university has given affiliation for the year 2017-2018, you are requested to allow **KLE College of law, (Karanataka Lingayat Education Society), Navi Mumbai, Maharashtra** for to admit students in **three year LLB, five year BA LLB law courses** with existing sections for the academic year 2017-2018.

The University/ College shall also comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of schedule IV in part IV of new rules of the Bar Council of India):-

“Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees five Lakh in shape of guarantee to fulfil all the norms of the Bar Council of India. The same shall be liable to be forfeited if norms are not complied with and same shall carry no interest.”

The letter is subject to the payment of guarantee amount as mentioned in the above rule. The Demand Draft of Rs. 5 Lakhs to be drawn in favour of “Bar Council of India” payable at New Delhi.



Note - That w.e.f 21.05.2016 the inspection fee for LL.B three year and five year regular course is Rs. 3 lacs for each course and for the Honours course it is Rs. 5 lacs, while the application fee is Rs. 50,000/- and the guarantee amount is Rs. 5 lacs.
