

2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency, mode and innovation in the internal evaluation.

Response:

The college initially followed a 100-mark external evaluation system for each subject during its commencement. However, in the 2019-20 academic year, the college adopted the **Choice Based Credit and Grading System (CBCS)**, implementing a 60:40 evaluation pattern. Under this system, 60 marks were allocated for university-level exams, and 40 marks were assigned to **Continuous Internal Evaluation (CIE)**. For B.L.S. and LL.B. students to pass, they needed a minimum of 40% in the combined Internal Assessment and Semester End Examination, with at least 30% in both components (12 out of 40 for CIE and 18 out of 60 for exams). They also needed a Grade E to pass each semester.

In the academic year 2022-23, the evaluation system shifted to a 75:25 pattern, with 75 marks for university exams and 25 marks for CIE. The CIE now consists of a 10-mark Periodical Test and a 15-mark Term Work Module or assessment decided at the semester's start. The LLM evaluation is managed by the University of Mumbai.

The internal evaluation system is designed to assess students' overall academic growth. It includes descriptive tests to enhance critical analysis and team-based research papers. Students are assigned topics based on their interests, with regular updates to their teachers, culminating in a final research paper and Viva Voce at semester's end.

The remaining final year examinations, i.e. 5th Year Five Year Law Course (Semester 9 and Semester 10) and 3rd Year Three Year Law Course (Semester 5 and Semester 6) are conducted by the University of Mumbai.

The LL. B Degree in either of the courses in Law will not be conferred upon a candidate unless the candidate has passed in, and cleared all the papers prescribed for each Semester Examination in accordance with the provisions relating to each Semester Examination. The performance of the students will be evaluated by the Examination to be conducted at the end of each Semester and also by his/her performance in the Practical Training Subject Papers as per the guidelines issued from time to time by the Bar Council of India.

Examination Question Paper Pattern BLS LL. B & LL.B. -Total 100 marks pattern consists of the following:

Q. 1 Ten Short Question (Not more than two sentences) – 2 marks each - 20 Marks.

Q. 2 Short Explanatory / Definitional or Analytical notes on any Four out of Six – 5marks each - 20 marks

Q. 3 Situational Questions (Problems) on any two out of three – 6 marks each - 12 marks.

Q.4 Essay type questions, four out of six – 12 marks each- 48 marks. Students can appear for the Examination in English / Marathi / Hindi. Question paper will be only in English and Marathi. However, the paper in the subject of "Legal Language and Legal Writing and General English" is to be written only in English

Standard for Passing the Examination

NEW PATTERN: The examination pattern, allotment of marks are as per the University of Mumbai circular no. UG/107 of 2018-19 dated 24th August, 2018, from the Academic year 2019-20 the Three years LL.B. & Five years B.L.S. LL.B programme is offered under CBCS system (60:40 pattern). R. 4437: - To pass the examination the candidates must obtain 45% marks in each paper/s and Practical/s separately. Those candidates who obtain less than 60% of the same sitting will be placed in Second Class. Those of the successful candidates who obtain 60% marks and more in all paper/s at one and the same sitting will be placed in the First Class.

If a candidate is allowed to join the next higher class as provided in the Ordinances relating to the different examinations, he will not be permitted to appear for the highest examinations unless (i) he has previously passed in the remaining subject/s of the lower examination, or (ii) he appears in that subject/s simultaneously with his appearance at the higher examination. In the latter case, however, he will, in no circumstances be considered to have passed in the higher examination, or any part of it, unless he passes in the aforesaid subjects (with the percentage, if any, required for the total) at the same time or within two years of his obtaining the marks necessary to pass in the higher examination or any part of it in which separate passing or exemption as permitted by the Regulation.

When a candidate owing to his failure to pass in the remaining subject/s of the lower examination within two years is not considered to have passed the higher examination or any part of it, he will forfeit all benefits occurring from the marks obtained by him in the higher examination, but the terms kept by him for such higher examination will be available to him for any further appearance at the examination. 5.3 CREDIT BASED EVALUATION SYSTEM

The performance of the learners shall be evaluated into two components. The learner's performance shall be assessed by Internal Assessment with 25% marks in the first component by conducting the Semester End Examinations with 75% marks in the second component. The allocation of marks for the Internal Assessment and Semester End Examinations are as shown below –

a) Internal Assessment – 25% (25 Marks)
