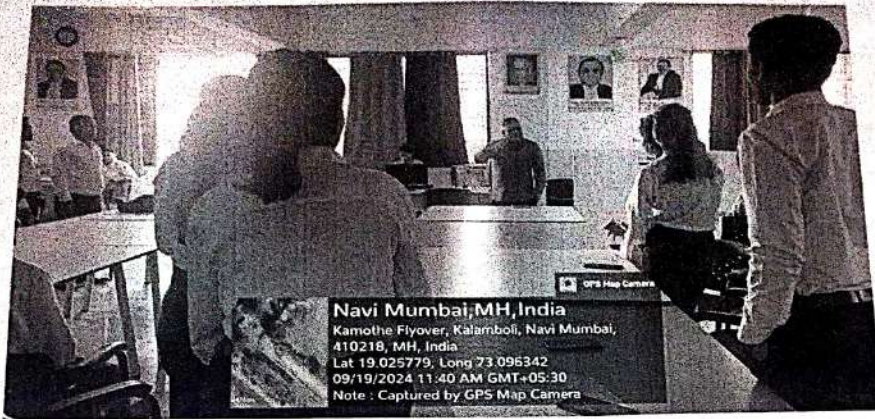

3. The students got the Metropolitan level exposure by virtue of collaboration with Times of India.



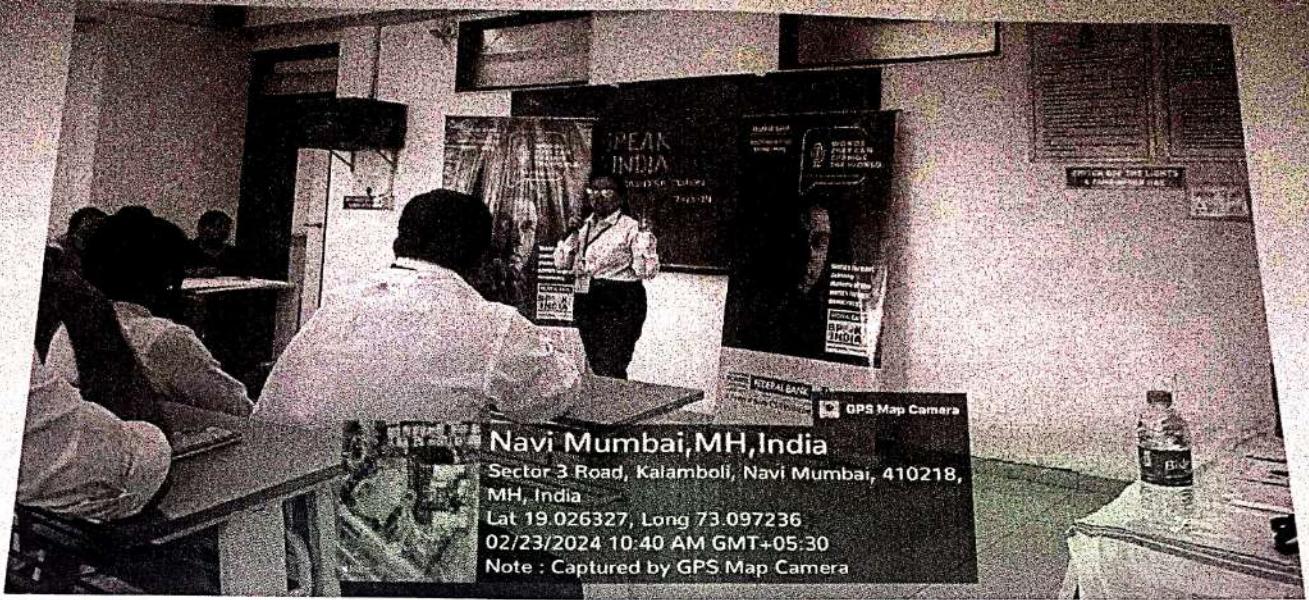
