
Event Outcomes:

the "Law Firm" (which expression shall unless it be repugnant to the context or the meaning thereof be deemed to mean and include its successors and each of the present individual members of the said Society and each of their respective heirs, executors, and administrators and/or successors) of the party of the Second Part.

Whereas "KLE" College of Law, Navi Mumbai, was started in the year 2016-17 under the aegis of the Karnataka Lingayat Education Society. (C) **DURATION**:

Though there was no agreement between the parties to this agreement, they have been mutually sharing the objective in this Agreement since 2018 and have been mutually assisting each other to achieve their common goals. However, to further strengthen the ties between the parties and to further achieve their goals as one the parties are entering this MoU which shall be valid for a period till the same is revoked by either of the party by giving notice in writing

of its intention. This MoU commences from the 1st day of January, 2023.

(D) ADMINISTRATION OF THE SIGNED MoU:

This MOU shall be effective and will come into force from the day the ONE authorized signatories of both the parties formally signs the MOU.

(E) TERMINATION / AMENDMENT OF MoU:

Both the parties will endeavor to resolve disputes if any arising between them in relation to this MoU by amicable means. If the same is not possible because of irreconcilable differences, then this MoU may be terminated by mutual consent of both the parties. Either party may terminate this MOU by a written notice. A minimum of one month prior notice must be sent to the other party prior to the effective date of termination.




